Set Up Fee

<p>One-time set up fee is \$99 per EDI customer. One half (\$49.50) is billed when you sign up. The other half (\$49.50) is billed after we finish testing with your EDI customer.</p>
<p>Optional interface to QuickBooks, Sage 50 (Peachtree), Sage 100 ERP (MAS), NetSuite, UPS Worldship, or FedEx is a one-time fee of \$499 which includes interfaces for all your EDI customers. Call for interface pricing with other accounting, shipping and warehouse systems.</p>

Set up fee includes turnkey implementation and testing for your company of all required EDI documents types with any customer. Your EDI customers can be located anywhere in the world. You can use MyB2B anywhere you have internet access.

Billing Category	Total Number of Documents Exchanged with all Customers	Total Monthly Fee
1	0 to 25	\$39
2	26 to 75	\$69
3	76 to 150	\$119
4	151 to 300	\$169
5	301 to 1,000	\$169 plus 15 cents per document over 300
6	Over 1,000	\$274 plus 8 cents per document over 1,000

The monthly fee does not start until after we finish testing with your first EDI customer.

Examples of documents: A Purchase Order is counted as a document. An Invoice is counted as another document. An Advance Ship Notice is counted as another document. Other document types are counted similarly. All 997 Functional Acknowledgment documents are free.

The monthly fee is sliding scale so that you do not have to choose a billing category. You are billed at the one billing category which corresponds to your total document usage each month with all of your customers.

Monthly Fee Examples

You can have as many EDI customers as you need and it does not affect your monthly billing category. You do not have to choose a billing category in advance. Monthly billing is based only on the total document volume with all of your customers. Here are some examples:

Example 1 - Billing Category 1

- 1 EDI customer
- 25 total documents exchanged with one EDI customer
- Total monthly fee - \$39

Example 2 - Billing Category 1

- 4 EDI customers
- 25 total documents exchanged with four customers
- Total monthly fee - \$39

Example 3 - Billing Category 2

- 1 EDI customer
- 70 total documents exchanged with one customer
- Total monthly fee - \$69

Example 4 - Billing Category 5

- 5 EDI customers
- 400 total documents exchanged with five customers
- Total monthly fee - \$184 (\$169 for first 300 documents+ \$15 = .15 X 100 documents)

Example 5- Billing Category 6

- 3 EDI customers
 - 2,001 total documents exchanged with three customers
 - Total monthly fee - \$354.08 (\$274 for first 1,000 documents + \$80.08 = .08 X 1,001 documents)
